



The crane shall be stopped (static) and the cab unmanned from initial helicopter radio check-in through helicopter departure. If possible, the crane boom shall be cradled when stopped. If not cradled, it shall be positioned clear of the Obstacle Free Sector and restricted portion of the Limited Obstacle Sector.</li> <li>○ Starboard/Aft Deck Crane – Crane-Helicopter SIMOPS authorized with the following restriction: <ul style="list-style-type: none"> <li>- Only inboard lifts aft of the multi-purpose tower (MPT) during helicopter approaches and departures</li> </ul> </li> </ul> </li> <li>• Radio Operator will relay the status of all crane operations during the 20-min call.</li> <li>• HLO will relay the status of all crane operations during the 5-min call.</li> </ul>
